With refereme to your application on the subject
noted above, I am directed to convey the permission of the
Director of Education, Delhi to your society to start a
new school in District ~~North~~ in Vikas puri area from class
I to XII subject to the following terms and conditins:

1. That the provision of Delhi School Education Act, 1973 and rules framed thereunder shall be observed by the society.
 2. That the management of the school will fulfill all the conditions laid down under rule 50 and provide all the facilities given in rules 51 of Delhi School Education Act, 1973 to the institution.
 3. That the management of the school will get the scheme of management approved from the Department immediately.
 4. That only qualified and trained teachers will be appointed and prescribed Govt. scales along with all allowances will be paid to the teaching and non teaching staff through crossed cheques.
- That the management of the school will not ask for grant-in-aid from the Deptt.
- That the school will not run for the profit of any individual association or a group of persons.
- That in case at any time the management of the school is unable to run the school, moveable and non-moveable property of the school will be transferred in the name of Director of Education, Delhi.
- That the management of the school will apply for grant of recognition of the school under the DSEA, 1973 separately and recognition will not be granted unless such statutory provision of sec.4(1)(a-f) read with rules 50 and 51 are fulfilled.

9. That all the recognised classes shall be run at one place only.
10. That the management of the school will obtain land from DDA in the name of the society for the purposed school through Directorate of Education Delhi.
11. That the proposed school will be run under the banner of ~~Anglo Vedic Public School~~ ~~Chitra Gupta~~ ~~Chitra Gupta~~ DAV College Managing Committee, Chitra Gupta Road, New Delhi and suitable funds for the purchase of land as well as construction of suitable building thereon as per the specification of the Department will be made available. The proposed school may be started only after the allotment of land as well as construction of suitable building within a period of 3 years from the date of issue of this essentiality certificate and adequate and sufficient accommodation @ 12 sq.ft. per student shall be provided for class rooms. The normal size of class rooms shall be 24 x 20'.

If recognition of the proposed school is not sought after fulfilling the above conditions within a period of three years of this permission to open a new school shall be treated as cancelled.
